4.3 General Government & Finance Committee - Councillor Gerrard

 An application has been submitted to the Housing Accelerator Fund as part of the Canada's National Housing Strategy. This strategy designed to facilitate growth and evolve neighbourhoods.

- The basis for the application is the recent housing study that was initiated by the Town to gain a better understanding of the housing needs in Neepawa.
- If Neepawa is approved for funding, there is a 3-year window to enable the capture of up to \$4.9 million. These monies to be utilized to remove barriers to development and assist with critical infrastructure.
- Key to receiving the funding is the translation of the investment into development that will result in the addition of a variety of new and affordable homes in Neepawa.

- The Legion Auxiliary donated their meal proceeds to Hand in amount of \$1,943.72.
- Currently considering the purchase of new kitchen equipment.
